



Consent, Release, Waiver and Indemnity

I, the undersigned, _____

do hereby declare that I am older than twenty-one (21) years of age and acknowledge that I will be taking part in a hunting expedition, which will involve but not be limited to, staying in uninhabited areas and travelling through such areas, whether it be by train, air, vehicle, boat, horseback, or any other conveyance or on foot and that my participation in any hunting, gamebird shooting, game viewing, bird watching, fishing, hiking, camping, swimming or any other outdoor or indoor activity, educational, recreational or sporting of any nature (“the activities”) involving any land, vehicle or aircraft or other asset of other parties, of Australian Hunting Safaris, or the owner of the land on which the activities take place shall at all times be subject to the following acknowledgements and conditions.

1. I fully appreciate the nature of the risks associated with my participation in the activities, in particular the risks associated with the conveyance of people in aircraft or in open vehicles in rough terrain. Walking over uneven ground and my proximity to rivers, loaded firearms, knives and other weapons, thorn bearing trees and shrubs, inhospitable outdoor conditions, unpurified water and dangerous or poisonous wild animals, birds, reptiles, insects and plants.
2. I acknowledge that I shall participate in the activities voluntarily and at my sole and absolute risk and that Australian Hunting Safaris cannot exercise any control whatsoever over the negligent and wilful acts of omissions of other parties or of the landowners participating in the activities.
3. I have been advised and record that I shall be fully entitled to decline to participate in any of the activities in my absolute discretion.
4. I declare that I am in good health, physically fit and capable of withstanding the rigorous nature of the activities, and that I have taken (or alternatively have personally declined to dispense with) full medical advice before undertaking the activities.
5. I undertake without question to comply immediately with every lawful instruction issued to me by Australian Hunting Safaris or the landowners and by any employee or representative of Australian Hunting Safaris and the landowner.
6. I hereby:
 - 6.1 waive and abandon any claim which I or my dependants may have against Australian Hunting Safaris and/or its employees, subsidiaries, affiliated or associated companies, agents or sub-agents (together “Australian Hunting Safaris”); and landowners whose land I visit;
 - 6.2 indemnify Australian Hunting Safaris and the landowners against all claims of whatsoever nature for which it/they may become liable to whomsoever; caused by or arising in any way in contract or in delict as a result of any activity whatsoever, including but not limited to any of the activities or any negligent act or omission on the part of Australian Hunting Safaris.
7. I acknowledge that:
 - 7.1 as Australian Hunting Safaris acts only as intermediary between me and the suppliers of certain services and therefore has no control over their actions, personnel, equipment, services or goods. Australian Hunting Safaris shall not be liable directly or indirectly for any loss or damage to property, or injury, whether physically or

mentally, or death of persons resulting from any act, omission, negligence or other fault or the suppliers of services, their agents, servants, employees and sub-contracts.

- 7.2 Australian Hunting Safaris emphasize that expedition to wilderness areas for purposes of hunting or adventure travel are, or can be dangerous or hazardous of nature. I voluntarily assume the risks inherent in such expeditions.
- 7.3 Australian Hunting Safaris shall not be liable to perform its obligations or carry out any of the activities if such failure is caused by events beyond its reasonable control preventing it from doing so, including without limiting the generality of the foregoing, Acts of God, strikes, lockouts or other industrial or labour disputes or disturbance, wars, blockages, insurrections, riots, civil commotion, earthquakes, typhoons, hurricanes or other storms, floods or acts by Government authorities.
- 7.4 Australian Hunting Safaris give no guarantee that either gamebirds or any other animal life will be located or that I will catch, see or kill any game or animal life.
- 7.5 I am aware that the activities contain inherent risks of illness, injury, death or loss of or damage to property, which may be caused by negligence of others, forces of nature and other causes known or unknown. I recognise that such risks may be present at any time before, during and after the trip that I am participating in under the arrangements of Australian Hunting Safaris. I am also aware that medical services or facilities may not be readily available during the time I am participating in this trip. I expressly assume any and all risks with respect to the activities and circumstances described herein and pledge not to claim from, or institute any action or application against, Australian Hunting Safaris on account of any losses, claims, costs, liabilities or damages and further, I agree not to claim the unenforceability of the arrangement.

8. The agreement shall be governed by Australian law.
